- 1. This Rental Contract consists of two pages. By signing, you hereby agree to all the terms, conditions, rates, and payment schedules herein.
- 2. The rental period shall begin on the day the bridge is picked up at our plant, and shall end when the bridge has been returned to our plant and all requirements of this agreement have been satisfactorily fulfilled. Payment for the minimum charge of thirty times the daily rate is due before the bridge is loaded onto your truck. Thereafter, bi-monthly invoices will be sent to you until the bridge is returned.
- 3. You agree to care for the bridge and maintain it in its present condition while it is in your possession, normal wear and tear accepted. The bridge deck is not designed for skidding operations; therefore, these type operations are not considered normal wear and tear. You hereby agree to pay for any cleaning, conditioning, repair work, etc. necessary to return it to its original condition.
- 4. You hereby acknowledge that A) you have thoroughly read and understood the installation, operation and maintenance manual furnished you by E & H for the bridge rented herein, and B) you have made yourself and your representatives, employees, agents and contractors fully aware of the proper use and maintenance of the bridge, and herein agree that the bridge will be used accordingly. You must comply with all weight limitations and installation instructions.
- 5. You shall, at your expense, comply with all federal, state, and local laws and regulations that pertain to the use, transportation, and operation of these bridges. You shall also obtain all permits required and follow all the "best management practices" for installing stream crossings.
- 6. You agree that you or your agent has inspected the bridge prior to loading and have noted any defects or damages on the front of this contract. All new damages will be handled as stated in Paragraph 3 above.
- 7. You assume sole responsibility for, and agree to immediately reimburse E & H, for any loss, damage, or destruction to the bridge, including consequential damages, from any cause whatsoever, from the time it is placed on your truck at our plant until the time it is returned to our plant.
- 8. You hereby expressly agree to release, indemnify, hold harmless, and defend E & H Manufacturing, Inc. from and against any and all claims, damages, losses, suits, attorney fees or other liabilities whatsoever, that may result from your transportation, installation, or use of the bridge, including personal or bodily injury, death, and/or damage to, or destruction of any property, regardless of the cause thereof.
- 9. By signing this contract, you hereby acknowledge and confirm that you have adequate and reasonable amounts of liability coverage for your activities and exposures, and upon request, will provide proof of insurance to E & H.
- 10. The bridge is available for purchase at your option. Should you decide to purchase the bridge, and pay it in full within the first ninety days of this contract, you may deduct all lease payments already made from the purchase price.
